## Chemical identification and uses

Lead (IV) oxide, also known as lead dioxide, is a dark brown, odorless powder primarily used in laboratory settings and various industrial applications.

## Potential exposures

Exposure to Lead (IV) oxide can occur in industrial/manufacturing facilities and during the handling of the chemical. Workers may be exposed primarily through inhalation, skin, and eye contact. Adherence to good manufacturing and industrial hygiene practices is essential to prevent or reduce exposure.

## Human Health hazards

Lead (IV) oxide is harmful if swallowed or inhaled. Prolonged or repeated exposure may cause damage to organs. It may damage fertility or the unborn child. Lead (IV) oxide has been classified by IARC as a probable carcinogen to humans (Group 2A) and reasonably anticipated to be a human carcinogen (NTP).

## Environmental Health hazards

Lead (IV) oxide is classified as toxic to aquatic life. Proper environmental control measures should be implemented to prevent further leakage or spillage.
